(5) Nominees must have:

- (b) Demonstrated their commitment to a humanitarian cause where there is extreme need;
- (c) Exhibited exemplary service to others within their community, their country or throughout the world.

(i) Definition of Exemplary Service:

- (1) Outstanding;
- (2) serving as an example;
- (3) admirable, commendable, ideal model, praiseworthy or exceptionable.

THE SUBMISSION

BROTHER WILLIAM (BILL) MCCALLUM began his career with this Union WHEN HE IMMEDIATELY SIGNED HIS Union Card transferring from CEUDA to UTE on the integration of GST. Bill has been an avid supporter of this Local and has served this membership well and long as a natural point of contact for employees seeking assistance regarding the death of loved ones. Bill is a registered / certified Funeral Director and Embalmer in his “other” life.

BROTHER MCCALLUM has always recognized the importance of wellness in our working environment. The needs and well being of others have always come before his own issues and concerns. Bill’s empathy concern and actions for the members here in London have greatly assisted our successes as a caring Local.

The members in London know they can count on him at any time. Bill inspires, motivates and supports and truly cares for the well being of all employees here in the London TSO.

Bill reaffirmed and demonstrated his caring for others when he stepped forward and offered his services to the United States Army’s plea for experienced embalmers to assist in the recovery of victims of Hurricane Katrina in New Orleans.

It was the hope of the U.S. officials that volunteers could endure for as much as two weeks recovering victims in the ruins of New Orleans and preparing their remains for release to their families.

The United States Army had Bill on a plane to New Orleans in less than 48 hours after receiving his offer of assistance. Medical immunization took up the first day and with the assistance and support of his wife and family in packing and making other arrangements he boarded a plane at 6:00 am the second day.

Bill and his team were deployed to the most devastated areas of New Orleans commencing their work a month after Katrina hit and within days after Rita. In fact, Bill worked five weeks straight, starting at 6:00 am and often not finishing until 10:00 pm, in 30 degree plus temperatures. Most often Bill worked in dreadful conditions within the wreckage of homes infested with alligators and poisonous water moccasin snakes. Armed escorts always accompanied his team. Collectively the teams recovered in excess of eight hundred human remains, assisting families achieve some form of closure from this catastrophe. I am humbled to know Bill and have him as a friend.

It is to be noted he was willing to give up his vacation time when management here in Ontario initially refused his request for Leave with Pay. The timely intervention of our National President to the C.R.A. Commissioner reversed this misconceived notion.

Bill is proud to be a member of UTE and has said this on more than one occasion. He is proud of UTE and proud to support UTE. Moments before departing for New Orleans I advised Bill of Sister Bannon's successful intervention. He told me he will be proud to advise everyone down there that it is because of his Union that he is able to assist. Bill epitomizes caring. It is not enough to just recognize a need but so important to act upon the need and assist in any way possible.

Bill always recognizes peoples' efforts with a ready smile, and kind words of appreciation. He is humble and modest of his own accomplishments. We benefit daily from his dedication and commitment, which is exemplified by this mission of mercy. If this recognition was awarded solely on courage then Bill has far exceeded the criteria.
